(Philippines & Overseas)

Given to an alumnus/alumna who has distinguished himself/herself through his/her professional accomplishments and sustained interest and participation in medical endeavors.

CRITERIA

1. An alumnus/alumna of the UP College of Medicine
2. Nominee and nominator should be UPMAS members in good standing\*
3. Of good moral and professional standing
4. At least 25 years from date of graduation
5. Distinguished himself/herself as teacher/trainor in a recognized medical school or Institution
6. Distinguished himself/herself as a clinical specialist or a public health specialist
7. Conducted researches and other creative works, which contributed to science, technology, national development policies and programs and the well being of the community he serves
8. Has held an important or a key position of leadership in the community, academe or the country

**OUTSTANDING EDUCATOR**

(Philippines & Overseas)

An alumnus/alumna who has devoted himself/herself largely to medical education and excelled in this endeavor.

CRITERIA

1. An alumnus/alumna of the UP College of Medicine
2. Nominee and nominator should be UPMAS members in good standing\*
3. Of good moral and professional standing
4. At least 15 years of teaching experience at a recognized Philippine medical school or institution
5. Has exemplified the qualities of a caring and compassionate mentor in teaching and advising of medical students/health caregivers
6. Has possess the personal qualities necessary to the practice of patient centered medicine
7. Received recognition through awards testimonials or citations for teaching from students or fellow faculty members

**OUTSTANDING RESEARCHER**

(Philippines & Overseas)

Given to an Alumnus/Alumna who has devoted himself/herself largely to outstanding biomedical research and health social sciences.

CRITERIA

1. An alumnus/alumna of the UP College of Medicine
2. Nominee and nominator should be UPMAS members in good standing\*
3. Of good moral and professional standing
4. Must have completed at least five (5) researches as **Principal Investigator**  
The copies of five (5) key papers by the Nominee as Principal Investigator must be submitted to the UPMAS Awards Committee.
  - a) The research findings and creative works should have contributed to science, technology, national development policies and programs or to the culture and well being of the country.
  - b) Researches have been published in peer-reviewed journals or presented in local/international conferences
5. Recognition in the form of citation, awards and other forms of recognition from academic institution, scientific or learned societies (national or international) given to the research creative works shall be taken into account.

**OUTSTANDING MEDICAL SERVICE AWARD**

(Philippines & Overseas)

Given to an Alumnus/Alumna who has devoted himself/herself to community medical service with selfless dedication inside and outside the Philippines

CRITERIA

1. An alumnus/alumna of the UP College of Medicine
2. Nominee and nominator should be UPMAS members in good standing\*
3. Of good moral and professional standing
4. At least ten (10) years rendering medical service with a hospital or institution, preferably one that is rendering service to the underserved area or with indigent & marginalized individuals
5. Distinguished himself as a committed, dedicated and relevant medical practitioner
6. Developed and implemented an innovative approach to rendering medical service within a hospital or institution, preferably with indigent & marginalized individuals.
7. Works with other disciplines within the institution and demonstrates a genuine partnership with the various sectors with the institution, including the patients.

**OUTSTANDING COMMUNITY and PUBLIC HEALTH SERVICE AWARD**

Given to an Alumnus/alumna who has devoted himself/herself to community service and public health service with selfless dedication.

CRITERIA

1. Alumnus/alumna of the UP College of Medicine
2. Nominee and nominator should be UPMAS members in good standing\*
3. Of good moral and professional standing
4. At least 10 years rendering community or population-based or public health service.
5. Has distinguished herself/himself as a committed, dedicated and relevant population-based worker or public health.
6. Contributed significantly to the improvement of the health and development conditions of a community or population group or sector, preferably an underserved or marginalized population or sector.
7. Developed and implemented an innovative community or population-based or public health service approach.
8. Community, population-based and public health service work are focused towards health promotion and disease prevention.
9. Works with all the discipline and sectors, especially the marginalized members of the community; and demonstrates genuine partnership with all the sectors in the development, implementation, monitoring and evaluation of community, population-based or public health programs.

**MOST DISTINGUISHED CLASS OF THE YEAR**

The alumni medical class that has collectively rendered the most contributions to the advancement of the profession through service to the country, the College and UPMAS.

CRITERIA

1. 2/3 of the members of the class are UPMAS members in good standing and nominated by UPMAS member in good standing\*
2. At least 25 years from date of graduation
3. The class members must have distinguished themselves as national/community leaders, teachers/educators, researchers and/or administrators of health related institutions

**ALUMNI FAMILY OF THE YEAR**

A family of medical alumni that has collectively distinguished itself  
in the service of the profession

CRITERIA

1. One or both parents are alumni of the UP College of Medicine
2. Alumni family members and the nominator should be UPMAS members in good standing\*
3. Of good moral and professional standing
4. At least one (1) child is a UP College of Medicine Alumnus
5. Members must have distinguished themselves in the practice of the medical profession
6. Members must have distinguished themselves in the academic community and/or in meaningful research.
7. Members must have involved themselves or are currently actively involved in civic and community work.
